### Submission Categories

- **Research Articles:** *In-depth analysis of legal issues (2,000–10,000 words).*
- **Case Comments:** *Critical evaluations of recent judicial decisions (2,000–3,000 words).*
- **Book Reviews:** *Reviews of recent publications in the field of law (1,000–2,500 words).*

**Notes:\*\*** Brief insights or observations on Current legal developments (1,500–3,000 words).

### Submission Process

- **Format:** *Submissions should be in Microsoft Word (.doc or .docx) format.*
- **Language:** *All submissions must be in English.*
- **Font and Spacing:** *Use Times New Roman, size 12, with 1.5 line spacing. Footnotes should be in size 10 with single-line spacing.*
- **Margins:** *1-inch margins on all sides.*
- **Abstract:** *A concise abstract of 150–250 words must accompany each submission.*
- **Keywords:** *Provide 4-6 keywords relevant to the submission.*
- **Cover Page:** *Include a separate cover page with the following details:*
  1. *Title of the submission*
  2. *Author(s) name(s) and affiliation(s)*
  3. *Contact information*
  4. *Acknowledgments, if any*

### Citations and References

- **Citation Style:** *Follow the Bluebook citation style, 21st edition.*
- **Footnotes:** *Use footnotes for citations, and ensure all references are complete and accurate.*



## Submission Procedure

- **Email Submission:** Send submissions to [journal@legalonus.com](mailto:journal@legalonus.com)
- **Subject Line:** Include "**Submission for LegalOnus Law Journal**" in the email subject line.
- **Response Time:** Authors will receive a confirmation email upon submission and can expect a decision within 8–12 weeks.

## Peer Review Process

- All submissions will undergo a double-blind peer review process to ensure impartiality and academic rigor.
- Authors may be asked to make revisions based on reviewer feedback.

## Originality and Plagiarism

- Submissions must be original and not under consideration by any other publication.  
*(AUTHORS ARE REQUIRED TO SUBMIT THE GOOGLE FORM AVAILABLE ON THE LLJ MAIN PAGE FOR DECLARATION AND PLAGIARISM CERTIFICATION), while submissions.*
- Submissions exceeding the 15% limit will be rejected or returned for revision.
- Author(s) should avoid any submission using AI.

- Authors retain copyright and are encouraged to share their work with acknowledgement to the journal.
